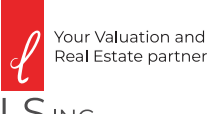

He has been actively involved in supporting the noble cause of the Rashid Pediatric Center for Children with Special Needs in Dubai, which caters to God's Own Children and he has been actively involved in raising funds for this Center. Last year for this 85th birthday he adopted his 5th school in collaboration with Dubai Cares.

He is the recipient of many awards and accolades.

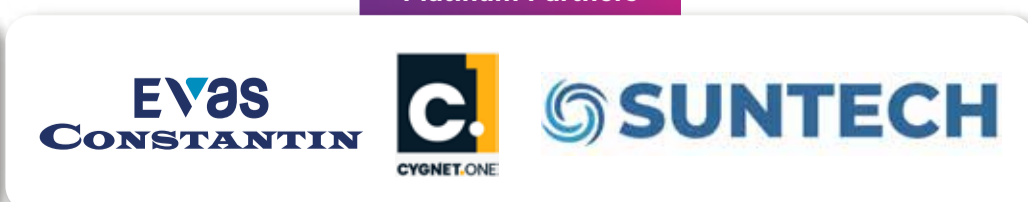
